NOTES TO FORM OF PROXY

- 1. The form of proxy is for completion by SA certificated holders and SA dematerialised holders who have "own name" registration of securities only. SA dematerialised holders who wish to attend the Annual General Meeting must inform their CSDP or broker of their intention and the CSDP or broker will issue them with the necessary documentary authorisation to attend and vote at the Annual General Meeting. Alternately, should they not wish to attend the Annual General Meeting in person, holders of securities may provide their CSDP or broker with their voting instruction and such CSDP or broker will complete all necessary documentation and action same in order for the holders of securities vote(s) to be taken account of at the Annual General Meeting.
- 2. Every holder has the right to appoint some other person(s) of their choice, who need not be a shareholder, as his proxy to exercise all or any of his rights, to attend, speak and vote on their behalf at the meeting. If you wish to appoint a person other than the Chair, please insert the name of your chosen proxy holder in the space provided (see reverse). If the proxy is being appointed in relation to less than your full voting entitlement, please enter in the box next to the proxy holder's name (see reverse) the number of shares in relation to which they are authorised to act as your proxy. If returned without an indication as to how the proxy shall vote on any particular matter, the proxy will exercise his discretion as to whether, and if so how, he votes (or if this proxy form has been issued in respect of a designated account for a shareholder, the proxy will exercise his discretion as to whether, and if so how, he votes).

- 4. The 'Vote Withheld' option overleaf is provided to enable you to abstain on any particular resolution. However, it should be noted that a 'Vote Withheld' is not a vote in law and will not be counted in the calculation of the proportion of the votes 'For' and 'Against' a resolution
- 5. Pursuant to Regulation 41 of the Uncertificated Securities Regulations 2001 (United Kingdom), entitlement to attend and vote at the meeting and the number of votes which may be cast thereat will be determined by reference to the Register of Members of the Company at close of business on the day which is two days before the day of the meeting. Changes to entries on the Register of Members after that time shall be disregarded in determining the rights of any person to attend and vote at the meeting.
- 6. To be valid, the instrument appointing a proxy (and where it is signed on behalf of the shareholder by an attorney, the letter or power of attorney, or a duly certified copy thereof) must (failing previous registration with the Company) be delivered to the Company's transfer secretaries to be received by them by 11am (SAST) on Tuesday, 20 July 2021 or, in the case of an adjourned meeting, at least 48 hours before the time appointed for holding the adjourned meeting at which the person named in the instrument proposes to vote or, in the case of a poll taken otherwise than at or on the same day as the meeting or adjourned meeting, for the taking of the poll at which it is to be used:

If more than one joint holder is present at the meeting, either in person or by proxy, the vote of the joint holder whose name stands first in the register of members shall be counted.

- 10. The completion and return of this form will not preclude a member from attending the meeting and voting in person, subject to any Covid-19 related restrictions in place at the time.
